## RESOLUTION 2017-18 #18

### COMPLIANCE WITH EDUCATION CODE SECTION 60119

#### SUFFICIENCY OF INSTRUCTIONAL MATERIALS

Whereas, the Governing Board of Saugus Union School District, in order to comply with the requirements of Education Code Section 60119 held a public hearing on September 19, 2017 at Saugus Union School District, 24930 Avenue Stanford, Santa Clarita, California 91355 and which is on or before the eighth week of school and which did not take place during or immediately following school hours.

Whereas, the Governing Board provided at least 10 days notice of the public hearing posted in at least three public places within the Saugus Union School District that stated the time, place, and purpose of the hearing, and;

Whereas, the Governing Board encouraged participation by parents, teachers, members of the community, and bargaining unit leaders in the public hearing, and;

Whereas, information provided at the public hearing detailed the extent to which textbooks and instructional materials were provided to all students, including English learners, in the Saugus Union School District, and;

Whereas, the definition of “sufficient textbooks or instructional materials” means that each student, including English learners, has a textbook or instructional materials, or both, to use in class and to take home, and;

Whereas between the 2008-09 through the 2017-18 fiscal years, the definition of “sufficient textbooks or instructional materials” also mean that all students who are enrolled in the same course within the Saugus Union School District , have standards aligned textbooks or instructional materials from the same adoption cycle, and ;

Whereas, sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in the following subjects:

*Scholastic, Big Day (TK) 2011*

*Reading/Language Arts (K-6) -Scott Foresman Reading Street 2010*

*Mathematics (K-6) –McGraw, My Math 2015*

*Science (K-5) -MacMillan McGraw Hill 2008*

*Science (6) -Harcourt for California 2008*

*Social Studies (K-5) – Scott Foresman 2007*

*Social Studies (6) - Harcourt for California 2007*
